Employment

Currently works as a consultant and expert in animal care and welfare related matters. Specializing in Dangerous Dogs, Wildlife Management, Dog Bites, Animal Cruelty, Municipal Government Animal Control, Hearing Officer and other animal related matters. Previously contracted with the National Animal Care & Control Association as Executive Director. Was employed by the City of Irvine Police Department for 29 years (retired 04/18). Has over 32 years in the enforcement of Animal Care and Control laws. Prior to Irvine employment, worked as an Animal Control Officer for the County of Orange, the City of Costa Mesa and as a Police Officer for the cities of Brea and Yorba Linda. In Irvine, worked as an Animal Services Officer, Senior Animal Services Officer, Program Specialist in Crime Prevention and Emergency Management, Animal Shelter Manager, Animal Shelter Supervisor, and Animal Services Supervisor. Has managed over 340 employees and volunteers in animal shelter settings. Has completed evaluations of municipal government animal shelter facilities staffing and operations, provided written recommendations for city management and created memorandums of understanding with other agencies.

As an Irvine Animal Services Supervisor, responsibilities included all animal related calls for service, animal emergencies and investigations in the City of Irvine. Supervised all Senior Animal Services Officers and Animal Services Officers, and provided regular training to department personnel. Handled and reviewed all animal related responses and cases, animal hoarding cases

and animal related emergencies within the City of Irvine and provided support for neighboring jurisdictions. Oversaw all animal related calls for service, wildlife data collection, wildlife management, commercial animal establishment inspections, animal event inspections, dangerous dog investigations (nuisance, potentially dangerous and vicious), animal bites, logging and maintenance of controlled substances used in the field for chemical sedation and immobilization, euthanasia protocol, animal disaster response coordination and animal cruelty investigations. Interfaced with California State Public Health Veterinarian and private practice veterinarians to improve rabies control standards and provide quality animal health care to impounded animals.

Has personally investigated approximately 15,000 animal abuse and neglect cases and has impounded and handled over 10,000 animals including, but not limited to, domestic dog, wolf hybrid, domestic cat, wild and domestic rabbit, opossum, raccoon, coyote, bobcat, mountain lion, skunk, owl, hawk, turkey vulture, duck, geese, chicken, rooster, egret, heron, marsh bird species, shore bird species, peacock, peahen, snapping turtle, other turtles, tortoise, tiger, panther, chimpanzee, alligator, caiman, serval, python, rattlesnake, other native snakes, other exotic snakes, deer, horse, cow, goat, sheep, pig, elephant, camel and sea lion. Testifies in criminal and civil proceedings that concern animal law violations and litigation reference animal bites and attacks. Is a court recognized expert in animal related subject matters. Has testified in Department of Consumer Affairs matters investigated by the California Attorney General's office.

Has created the first Coyote Management plan in Southern California which is used by the City of Irvine. Has shared the Coyote Management plan with several animal care and control agencies in Southern California who have implemented the plan. Recognized as an expert in the field of coyote management by Southern California agencies and California Department of Fish and Wildlife. Has written policy and procedure for Irvine Animal Services and local ordinances pertaining to animal care, welfare and wildlife. Has assisted other animal control agencies with investigations including, but not limited to, animal abuse investigations, animal bite investigations, dangerous dog investigations, local disaster response and acted as a Hearing Officer in dangerous dog proceedings.
